8. Outlook for March 2014

In March there is no redemption of government financial liabilities coming from government bonds and Tbills.

On the base of issuer's decision there will be auction of government bond \check{SD} 219 (coupon fix rate 4.625 % p. a. with 2.84 years to maturity) and of government bond \check{SD} 223 (coupon fixed rate 3.375 % p. a. with 10.67 years to maturity). Auction of both bonds will take place on March 17th.
