This declaration shall be changed (or revoked/replaced only by a written declaration with notarized signatures of the persons authorized to act on behalf of the owner/holder/Accountholder (as provided in the Conditions and/or applicable legal regulation). ARDAL is entitled to request update or confirmation of this declaration or data contained herein before any payment.
